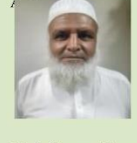

PRESENTATION OF ANNUAL REPORT, 2022

The Chairman Khyber Pakhtunkhwa Public Service Commission presented the Annual Report of the Commission for the year 2022 to the Hon'able Governor Khyber Pakhtunkhwa, Haji Ghulam Ali, on 2nd June, 2023. The Chairman highlighted the achievements of the KP PSC and apprised the Hon'able Governor of important administrative issues being faced by it. The Hon'able Governor showed keen interest in the PSC affairs and particularly its role in the Selection Boards of the public sector universities of the province. The Hon'able Governor assured all support in that behalf lauding the achievements and efforts of the PSC during the year 2022.

The Hon'ble Chairman extended gratitude to the Hon'ble Governor, Provincial Government and all Provincial Departments of Khyber Pakhtunkhwa for assisting the Commission in its functioning.



APPOINTMENT OF MEMBER

Dr. Razia Sultana was appointed as member of Public Service Commission against vacant position of female quota. She took oath of office on 28th April, 2023. The Chairman KP PSC administered the oath. With her appointment, the 12 member strength of the Commission completed. The Commission welcomed her as Member PSC.



10TH MEETING OF THE COMMISSION

Meeting of the Commission was held on 09.06.2023. The Commission showed satisfaction on implementation status of the decision taken in previous meeting of the Commission.

The Commission took important decisions on agenda item that included amendments in regulation 34(c) regarding inter se merit of candidates in various subjects having common seniority, examination SOPs for body search and requiring candidates to reach examination hall 30 minutes before test timing, creation of QR code system for recommendations of candidates and retired/ in-service employees identity cards of KPPSC, approval of amendments in KP PSC Officers and Servants (Terms and Conditions of Service) Regulations, 1985, recommended by SSRC and unclaimed qualification/ experience of candidates in online application forms etc.



RECOMMENDATIONS ISSUED DURING THE 2ND QUARTER

The Commission finalized recruitment against the following 344 posts in various departments. Out of 33897 applicants, 1854 candidates were interviewed and recommendations of 336 candidates including 13 posts pertaining to Minority Quota were sent to the department concerned. Eight posts remained unfilled; 5 to Minority Quota and 3 to General quota. Post-wise details are as follows:-

PHYSICAL TEST

The Commission conducted physical test for the post of Assistant Superintendent Jail (BPS-16) in Inspectorate General of Prisons, Khyber Pakhtunkhwa for 9531 candidates with effect from 27th March, 2023 to 18th April, 2023 (Adv; No 04/2022 Sr. 62). As per required criteria physical standard was measured; height 5 Feet 7 inches and chest 33*34 inches without expansion and 33*34 $\frac{1}{2}$ with expansion. Total candidates were 9527 wherein 4750 (50 %) appeared for physical test. 4303 candidates (90 % of appeared) declared qualified for the next phase i.e. ability test and 447 (10%) did not meet for the required criterion.

PRACTICAL TEST

The Commission conducts practical test/exam for Senior Scale Stenographer, Stenographer cum Judgment Writer etc. in its IT Lab. Candidates are required to go through the required standard in respect of typing/ shorthand speed in the presence of an Examiner for dictation having excellence expertise in the field and other Commission's technical and supervisory staff. Normally, candidates required proving 45 and 70 typing and shorthand speed respectively. In the Quarter under report, the Commission conducted 6 such practical tests against 20 posts of Senior Scale Stenographer (BPS-16) in various provincial departments for 956 candidates w.e.f. 03.04.2023 to 14.04.2023 where only 193 candidates appeared.

RESULT OF WRITTEN EXAM: OF ASSISTANT SUB INSPECTOR OF FAST TRACK PROMOTION

The Commission announced the result of Assistant Sub Inspector (Fast Track Promotion) in Police Department on 23rd May, 2023. After scrutiny of 1605 applications, 1009 candidates were found eligible for written exam wherein 595 appeared in which 272 (excluding 2 cases sub judice) or 46 % in respect of appeared candidates qualified for viva voce. Similarly, 321 or 54 % candidates did not qualify the exam. Ironically, the failure ratio was higher in professional than academic subjects. The subjects 'Selected Parts of Basic Recruit Course' and Police Practical Work' proved tough for in service candidates in the Police Department.

RESULT OF WRITTEN EXAM: FOR THE POSTS OF ASSISTANT SUB INSPECTOR TRAFFIC WARDEN (IN-SERVICE QUOTA)

The Commission announced the result of written exam for 77 leftover posts of ASI Traffic Warden (BPS-11) In-Service quota on 23rd May, 2023. Scrutiny was conducted before the exam. After scrutiny, 84 candidates out of 175, were found eligible wherein 66 candidates appeared in the written exam. 34 candidates passed and 32 did not qualify. Astonishingly, majority of the candidates who did not qualify failed in professional subjects i.e. Police Practical Work and Selected Parts of Basic Recruit Course.

POSTS ADVERTISED

In the Quarter, the Commission advertised total 84 posts; 73 fresh and 11 leftover of Civil Judges-Cum-Judicial Magistrate/Alaqa Qazi in Peshawar High Court. Details are as under: -

PROCUREMENT OF FURNITURE

KP PSC has always been doing efforts to facilitate the candidate to the maximum extent. The Commission procured 300 tablet chairs (275 right handed & 25 left handed) for candidates appearing in various written examinations and ability tests. Equipped with new furniture, Commission now has the facility to conduct test and exam for about 600 candidates within its premises. Moreover, 150 easy chair/comfortable chairs for waiting room of candidates attending PSC for interviews were also purchased. Total cost of the procurement was Rs.3.9 million.
