I am directed to refer to Establishment Department Notification No.SO(Policy) (E&AD)4-4/ 2022 dated 22.12.2022 (copy enclosed) and to state that the Provincial Govt: of Khyber Pakhtunkhwa has revised the zonal allocation for initial recruitment.
