ABILITY TESTS FOR THE POSTS OF SECONDARY SCHOOL TEACHER (SST BS-16) AND VARIOUS OTHERS IN DIFFERENT DEPARTMENTS

In the quarter under review, the Khyber Pakhtunkhwa Public Service Commission conducted various ability tests, most of the cases SSTs for **70186** candidates against **762 posts**. As the number of candidates in SST Maths/Physics, Bio/Chemistry was disproportionately greater, separate test for each zone was conducted to ensure smooth conduct of the exam. APPOINTMENT OF THE SECRETARY KP PSC

The Commission extends welcomes and wishes him success in his new assignment.

ENHANCEMENT OF REMUNERATION RATES

The KP PSC faced one of the outstanding issues of low remuneration for supervisory staff, examiners, advisors, subject specialist etc. To attract and retain quality services of the professional, revising the remuneration rates was inevitable. The Provincial Govt. on 26th January, 2026 addressed this issue by revising the rates that will help the Commission for expeditious finalization of the recruitment cases. The Commission extends its gratitude to the Govt. for resolving the issue. Similarly, the Commission expects the Govt. for the enhancement of PSC Allowance from 20% of the mean of 2016 pay scales to 50% of the mean of 2022 pay scales, which has been frozen for nearly a decade, despite soaring inflation and a revised pay structure.

WRITTEN RESULT OF COMPETITIVE EXAMINATION FOR THE POST OF MEMBER OF SERVICES

The Commission, on 26th January, 2026 announced the result of the written part of the competitive examination for 248 posts. Total 1147 candidates applied and 245 (21%) (less than the number of advertised vacancies) appeared in the written examination wherein 16 (7%) qualified.

WRITTEN RESULT OF COMPETITIVE EXAMINATION FOR THE POST OF ASSISTANT SUB-INSPECTOR (FAST TRACK PROMOTION)

The Khyber Pakhtunkhwa Public Service Commission, on 18th February, 2026 announced the written result of 584 posts of Assistant Sub Inspector under Fast Track Promotion in Police Department. Out of 6395 total candidates, 3533 appeared wherein 169 (5%) qualified the written exam. The following table shows the ratio of passed and failed candidates in each paper:-

The Computer Literacy paper proved to be a challenging component of the examination, with only 10% of the candidates passed. In contrast, the candidates demonstrated a strong performance in the Urdu paper, with 78% qualified.

C. OTHER POSTS ADVERTISED

The Commission vide its Advertisement No. 02/2026 also advertised **229** posts in various cadres in different departments wherein **19552** candidates applied.

FINALIZATION OF PHYSICAL TEST FOR THE POST OF ASSISTANT SUB INSPECTOR (EXECUTIVE CADRE)

The Khyber Pakhtunkhwa Public Service Commission finalized the Physical Test for 27042 candidates for 169 posts of ASI (Executive cadre) in Police Department. The Physical test was commenced from 1st October, 2025, was, initially, expected to conclude in December, 2025. However, due to unavailability of sports grounds, the process was concluded on 14th February, 2026. The written exam for the qualified candidates is scheduled to be held from 9th June, 2026 to 12th June, 2026.

RECRUITMENTS FINALIZED

The Commission finalized the recruitment process for **403** posts by disposing off **29520** applications wherein **2051** candidates were interviewed. **383** candidates were recommended to the Govt. for appointment while **20** posts remained unfilled due to non-availability of eligible/suitable candidates. 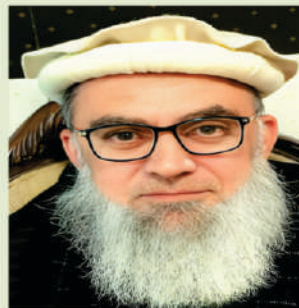
RECRUITMENT PROCESS FOR LECTURER POSTS RESUMED

The KP PSC, vide its Adv. No. 05/2022, had advertised various posts for male/female lecturer posts in different subjects. In response to a request from the Higher Education Department (HED), Khyber Pakhtunkhwa, the recruitment process for certain subjects was put on hold. The Commission subsequently conducted recruitment processes for the required subjects when requested by the Department.

Finally, on 6th February, 2026, the HED approached the Commission to resume the recruitment process for Male/female lecturer in the 5 remaining subjects: Geography, Pashto, Home Economics, Psychology and Zoology. Accordingly, the Commission has scheduled Ability Test for the aforementioned posts of Lecturer from 11th May, 2026 to 13th May, 2026.
